- A photocopy of undergraduate diploma
- A photocopy of last completed study level (Masters or PhD), if applicable
- A transcript of grades of the last completed degree (under or postgraduate); if this program was completed outside Slovenia, submit also the official grade scale
- A written confirmation of the tuition costs and duration of studies including the name of the candidate, issued by a Slovene higher education institution
- A written confirmation of the education institution confirming the studies will take place in Slovenia for the whole duration of studies.
- A photocopy of documents indicating additional financial sources for this study program from legal entities other than Ad futura (in Slovenia or abroad)
